# **Terms of Service**

December 18, 2024

Welcome to drovi ("we", "our", "us"). These Terms of Service ("Terms") govern your participation in our promotional game ("Game"), which is accessible through our Next.js application located at [Your App URL]/terms (the "Site"). By participating in the Game, you agree to be bound by these Terms. If you disagree with these Terms, please do not participate in the Game.

# 1. Eligibility

- Age Requirement: The Game is open to individuals 18 years of age or older at the time of entry.
- **Geographical Restrictions:** The Game is open to residents of anywhere the winner will be paid the equivalent of £250 in your currency of choice.
- **Legal Compliance:** By participating, you confirm that you are not a resident of any jurisdiction where such participation would be contrary to local laws.

#### 2. How to Enter

To enter the Game, participants must:

- 1. **Provide Information:** Submit your **full name** and **email** through our sign up page.
- 2. Answer Questions: Answer 4 questions about your goal from our chatbot.
- 3. **Submit Entry:** Complete the entry form as directed within the chatbot.

#### Limitations:

- One Entry Per Person: Each participant is allowed only one (1) entry into the Game. Multiple entries from the same individual will result in disqualification.
- **No Purchase Necessary:** Participation in the Game is free of charge and does not require any purchase or payment.

### 3. Prizes

We are offering the following prizes:

- **Grand Prize**: £250 (one winner)
- Runner-Up Prizes: T-shirts and/or 6 month free premium membership to our drovi app (four winners)

#### **Prize Details:**

- **Grand Prize:** £250 will be awarded to one winner.
- Runner-Up Prizes: Each of the four runner-up winners will receive either a t-shirt, a
  premium membership, or a combination of both. The specific prize for each
  runner-up will be determined by drovi.

#### **Prize Restrictions:**

- Prizes are non-transferable and cannot be exchanged for cash or other alternatives.
- drovi reserves the right to substitute a prize with another of equal or greater value if the advertised prize becomes unavailable.

#### 4. Winner Selection and Notification

• **Disqualify Entries:** Remove any entries that violate these Terms or are incomplete, fraudulent, or otherwise ineligible.

 Modify or Cancel the Game: Change, suspend, or terminate the Game at any time for any reason, including technical issues or fraud, without prior notice.
